



TERMS & CONDITIONS

1. US and International Shipping Terms and Conditions:

All orders will be shipped with freight paid by customer (pre-paid add, billed on customers shipping account or freight collect.)

There will be a 21 Business Day lead time on all orders unless otherwise specified by AES

2. Shipping Methods:

US: All Pre-Paid Add options will ship UPS, we can ship with customers shipping account for any carrier they choose.

International Orders: All customers that choose Pre-Paid Add will ship UPS. A \$35.00 Processing Fee will be charged for all shipments that AES must process, this fee will not be charged if Customer arranges product pick up. Buyers are responsible for ALL Duties and Fees.

3. Payment Methods:

International: Payment will be received, either by Wire Transfer (\$35.00 Transfer Fee added to total), Credit Card or Check, prior to order being shipped.

State Side: All Sales are pre-paid unless Credit has been applied for and granted (First order will still be pre-paid for customers approved for Terms). Customers that are approved for Credit will be on Net 30 Terms (NO EXCEPTIONS), if payment is not made to these terms, Customer will be placed on pre-paid Terms ONLY. Payment can be made by Wire Transfer (\$25.00 Transfer Fee added to total), Credit Card or Check.

Repair work: ALL repair work will be paid prior to shipment regardless of customers agreed payment terms.

4. Prices:

Prices are subject to change without notice. All prices listed are in US Dollars.

5. Quantity of Product Ordered:

There is no MQR (Minimum Quantity Required), any order of more than 50 Units requires a 50% deposit of final sale price upon placing the order and the remaining amount, plus any shipping cost, will be due 30 days after shipment of the final unit, with approved credit.

6. Product Returns:

ALL SALES ARE FINAL. Returns for repair will not be accepted without a Return Merchandise Authorization (RMA) Number. An RMA request may be filled out online at www.americanequipmentsafety.com, you can find this link under the "Contact Us" tab.

7. Warranty:

No claims allowed unless made within one (1) year from the date of the invoice for electronics and general operation of the unit and five (5) years for any housing damage. Credits or replacements will be issued only after an examination of the returned products indicates customer error or misuse was not the cause of failure. **THERE IS NO WARRANTY ON PRODUCTS USED FOR R&D PURPOSES.**

8. Agreement:
